


Recycling targets for municipal waste:

Targets		By 2025	By 2030	By 2035

- Add on to existing separate collection obligation for paper and cardboard, glass, metals and plastic
- By 2035 the amount of municipal waste landfilled must be reduced to 10% or less of the total amount of municipal waste generated.




WFD revision - Main issues for discussion



- Ambitious waste prevention with concrete targets (also on reuse + cap on residual waste - target of 120 kilograms per capita by 2030 and of 100 kilograms per capita by 2035)
- Harmonization of separate collection
- Introduction of a definition of high-quality recycling, chemical recycling & recovery technologies + amend the waste hierarchy;
- Mandate mixed waste sorting & R1 formula for incineration (remove?)
- Revision and extension of the EPR scope

Batteries Regulation

- Batteries Regulation is now entering final stages of trilogues
- Timeline: conclusion before end of French Presidency (next Thursday) looks unlikely – CZ to take over from July – adoption expected end 2022
- Sustainability "chapters" remain unconcluded, including Article 11 – focused on replaceability
- In Article 11 key issues remain under discussion: spare part availability and wet conditions
- In parallel JRC guidance being developed to interpret this article and list exemptions...

Ongoing initiatives


- Proposal for Ecodesign Regulation for Sustainable
 Products (DG ENV, GROW, ENER, adopted 30 March 2022)
 - o introduce more detailed performance and information requirements for certain product categories through future delegated acts.
- The Right to Repair initiative (DG JUST, Q3 2022):
 - o focus on encouraging repair of goods after purchase
- The Green Claims initiative (DG ENV, Q3 2022)
 - more detailed technical requirement to substantiate environmental claims (linked to environmental life-cycle assessments of products)
- The Sustainable Consumption pledge (DG JUST, ongoing non-legislative initiative - pilot phase in 2021 – new call published in 2022)
 - Opportunity for companies taking a voluntary pledge to support sustainable consumption, beyond what is required by law.





- Ongoing revision of the EU Circular Economy Monitoring Framework
- Timeline conclusion of initiative expected end 2022
- New indicators expected on Consumption and Material Footprint

CE Taxonomy: timeline & next steps

Taxonomy delegated acts setting criteria for substantial contribution to the other 4-non climate objectives:

- 1) sustainable use and protection of water and marine resources
- 2) transition to a circular economy
- 3) pollution prevention and control
- 4) protection and restoration of biodiversity and ecosystems

Timeline

- Platform on Sustainable Finance (non-binding) <u>recommendations</u> published on 30 March 2022
- Commission to adopt delegated acts (no clear timeline, EC is delayed so likely not by the end of 2022)

Consultation:

Commission is expected to hold a stakeholders consultation on the draft acts, before adoption
